All these professional questions and answers relevant to the sudden premature unexpected deaths of human beings must be available via the internet as soon as possible for scrutiny. The focus must be accuracy, competence, and professional questions and answers relevant to sudden unexpected premature deaths. Medical examiners who do not have these skills or cannot provide such public services via the internet must be replaced as soon as possible.
